Claimant's appearance is suspicious i.e. dirty calloused hands tanned wears work clothing

A gut feeling or suspicion about claim

Claimant has PO Box and or non-published phone number

Demands are excessive

Claimant has skills in a trade where he or she can work for cash

Injury doesn't typically match length of recovery or there are conflicting medical reports

Prior claims history
