Financial Statement Summary for the month ending May 31, 2023:

Total Assets and Liabilities & Equity were \$411,071.90.

The total checking/investment/savings balance was \$71,913.17

The full 5 months of the Common area Reserve collection YTD is \$25,000.

Liabilities include Accounts Payable of \$2,283.79 with the issue of negative accounts payable still being researched by the accounting firm of Klatt & Associates.

The statement of operations reported a Net Operating Revenue of \$27,162 and a Total Net Revenue of \$28,176. The Total Operating Revenue figure included an Unrealized Gain of \$1,602 and a Realized Gain of \$804 YTD on the investment portfolio.
