Guest Speaker Allan Montgomery from Honor Flight Houston spoke to the group about the free of charge flight for veterans of WWII, Vietnam and Korea to Washington D.C. to see the War Monuments. Signup is at Honorflighthouston.org and all expenses are covered. This is scheduled as donations are available with each flight costing \$40,000. The trip is for 2 days and each flight consists of 23 veterans, staff and 2 medics. You must agree to use a wheel chair, which is provided while there. They have been able to do 4 flights per year but have reached 8 flights per year when funds are available.
