**No unentered dogs loose, please.**

This test is open to all Poodles. Poodle Club of America, Inc. rules will be used. Upland Certificate Rules and Guidelines are available from Jaci Bowman, PCA Upland Certificate Chairperson, 128 E. Capitol Dr Hartland, WI 53029, Jacibowman@yahoo.com, or are online at poodleclubofamerica.org or uplandpoodle.com.

**Entry limited to 30 total entries.**

Dogs must hold a UWC to be eligible to enter UWCX.

If Entries do not fill by closing date, there may be gate entries available pending an adequate supply of birds.

A waiting list will be maintained in case of an over draw of entries.

*If there is an over draw of entries by the closing date, the dogs will be accepted into the test as follows. This procedure is to permit as many different Poodles to be entered as possible.*

*Dogs not holding a certificate in a particular level will be given preference to dogs holding a certificate in that level. **Please be sure to put the certificate titles the dog holds on the entry.***

*After that, preference then will be given in order to: a dog with an entry into a single stake; and then to a dog with entry into 2 stakes, with preference given to the lowest level stake first.*

The Test will commence at 8:00 am. Meet and check in by 7:30 at headquarters, then proceed to test field. Running order will be sent to each exhibitor and will be available at the site.

**ALL PARTICIPANTS and GALLERY,**  
**MUST WEAR BLAZE ORANGE IN THE FIELD.**

Only gunners approved by the Hunt Test Committee will be used.

Smoking will not be allowed in the field.

Please bring adequate water for your dogs and yourself. Be prepared to provide water for your dog in the field.

The club assumes no responsibility for any loss, damage, or injury by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators.

**Birds:** Chukar Partridge, Pheasants or Quail may be used depending on availability of birds

**Prizes:** Each qualifying dog will receive a rosette ribbon as well as a game bird band, and braided slip lead. Qualifying UIC,UWC and UWCX Poodles are eligible for Poodle Club of America, Inc. certificates.

Additionally dogs currently holding the PCA WC or WCX are also eligible to receive The Hunting Poodle certificates.

**Bitches in Season and injured dogs:** In Season bitches cannot run. A full refund will be available for bitches in season or injured dogs with a letter from veterinarian, less bird costs.

**Food:** Will be available for judges and workers. All others please bring your beverages and lunch.

**Guidelines:** There is some shade available but not necessarily near the test location. Please bring your own shade and water. Dogs must be on leash or confined when not running in test. Electronic collars are not permitted.

**Directions from Host Hotel:** North on Hwy 13 for 24.7 miles to Hwy DE-16/DE-36, go East on DE-16/DE-36 for 2.5 miles to Rd 602 and make a right turn ( south) to 12613 Rd 602, Greenwood DE 19950. It is approximately a 45 minute drive from the La Quinta, Sailsbury.
