### **Online Upgrade**

In an effort to simplify the management of our Home Owners Association, we have converted our books from spreadsheets to an online bookkeeping system. The software offers a simple and intuitive dashboard; a portal for managers and members; the ability to send invoices and late fee notices automatically; collection of HOA dues online; auto pay and scheduled payments. It also allows for email communications and text messaging. Members have the capability to submit suggestions for maintenance actions and the system allows managers to sync/reconcile the bank account, issue HOA violations, and store all documents in the Cloud to share.

Please take a few minutes to register for an account at **www.PayHOA.com**. A manager will then accept your request allowing you to check out the website, and pay your current dues and/or schedule your auto pay.
