#### Secretary's Report

Hello again Brothers and Sisters,



Well, hopefully everyone made it through another rough holiday season and I want to thank all of you for the hard work you had to endure to get through it! There are so many things swirling around within the post office right now with mandates, being overworked, stress levels, COVID, and trying to juggle work and a family life! I will keep my report to

the basics this time, but it is a lot of information to get out to all of you.

First on the COVID issues. If you have tested positive, please go online to NALC.org website. In the search area up top, search for COVID 19 ca-1 and the first item that pops up in the list is called the FECA outreach with pictures of clock faces and a bullseye. Click on that, and it will take you to a tutorial on how to fill out the ca-1 form for COVID. You will need a couple of things before filling out the ca-1 and they are a photo of a positive antigen test that came from a medical provider (not a Rapid test) and your supervisor's email address. If you don't have the supervisor's email address, you can put in their first name and then usps.gov and that should suffice for now. If you know your supervisor's email, please make sure that goes in. The reason for this is to get you covered under COP and also protect you further along in your career in case something comes about in the future! If you are one of the unfortunate individuals that has caught it more than once, you will need to fill out a new ca-1 every time! It should go easier the second time as you already have a profile set up in ECOMP.

Continuing with COVID, MASKS, remain a hot topic in many installations. I personally don't understand it being a hot topic, but here it is: it is a Postal Policy and therefore a rule. Not unlike any other rule in the post office, like wearing your seat belt or delivering all your first-class deliverable mail. It's a rule and therefore you are subject to punishment if you do not follow it, plain and simple. Leave the politics out of it! If you have a medical reason for not wearing one that is a discussion with you and postal management and they can issue a face shield! I have heard people bring up all kinds of scientific reasons for this that and the other, but it doesn't matter, it's a rule! You're inside the facility, for most of us, less than 2 hours a day!

State convention is coming up on April 29-30 in Colorado Springs. There was a snafu with the hotel we had booked and we have arranged with another to take those same times. Contracts should be signed soon and fliers will be sent to all branches for the wonderful things we will be doing. Planned so far is a golf event at Top Golf where we will have pre-registration and a fun night for golfers and non-golfers. For those golfing we will need you to register for the event. That will take place the night before on the 28th. There will also be a CPR/first aid class taught on that day as well. #### Treasurer's Report

Brothers and sisters

I hope everybody is well! I would like to thank the State and the NBA's office for putting on a great steward training. We are planning on having some training at the State Convention this year as well. There is some talk



of some treasurer training. If everything works out, I encourage all interested parties to attend. There is a lot to the job. The financial responsibilities are very important. Hopefully all branches got the W-2's, W-3, 940 and 941 mailed off or submitted.

As many may have noticed, our dues went up. The NALC constitution Article 7 states in part:

Sec. 2 (a). There shall be a minimum dues structure which shall consist of the following:

Each member shall pay monthly dues equal to two hours base pay for an NALC Grade 1, Step D letter carrier employed by the United States Postal Service. After November 24, 2018, each member shall pay monthly dues equal to two hours base pay for an NALC Step D letter carrier in the consolidated career City Carrier grade level (Table One) implemented on that date. One third of such dues shall be allocated to the national union and shall be designated the national per capita tax. The remaining two thirds of such dues shall be allocated to the member's branch and shall be designated minimum branch dues

It is the responsibility of each branch to go through their dues rosters and make sure all members are paying the correct amount. The listing should be checked for inaccuracies in the dues amount withheld from each member's pay-check. If an amount is incorrect, the branch should notify the membership department immediately, providing members name and social security number or NALC membership number and the correct dues amount. For more information on this, go to NALC.org and it is in the NALC Branch Officer's Guide to Finance and Administration.

#### Director of Retiree's Report

Greeting and Salutations Colorado State Retirees:



I have had several calls regarding these two provisions. The people I am hearing from wanted me to explain these two Legislative items in plain speak. I have done my best to drill down H.R 82 and S. 1302, but please be aware that these are very complicated pieces of Legislation. You can read the fact sheets for yourself at NALC.org, and I would encourage to do just that. I do have an ask of the retirees.

After the Postal Reform Act is passed, contact your representative and ask them to support these provisions.

Windfall Elimination Provision: This provision was enacted in 1982 and reduces the Social Security benefit of retired public employees (federal, state and local) who also worked in Social Security-covered private sector employment. This provision hurts CSRS directly with a complicated formula designed to reduce the benefit they have rightly earned; through the years they were paying into the Social Security fund. It will continue to affect these individual until it is corrected. It is imperative that we stand up for our retirees and protect them. Their ability to care for their financial health into their most vulnerable years,

will be seriously affected. With food, medical care, and housing prices soaring around the country, our work to rid them of this burden is more important than ever.

Government Pension Offset: This provision was enacted in 1977 and reduces or eliminates the spousal/survivor benefit for those married to CSRS employees; unless they qualify under their own work history. The benefit is reduced or even done away with altogether when an arbitrary financial threshold is reached. This reduction or elimination could financially devastate the individual left behind after the passing of one of our Retirees. The support provided by this benefit could make the difference in being able to afford adequate, healthy food, safe housing, as well as medical care. Our retirees worked for many years ensuring and protecting the contractual rights of all Letter Carriers, it is only right that we stand by them now and make sure they are not left to suffer financially in their golden years.





# How to Communicate Effectively with Legislators Why advocate?

Every piece of legislation starts as an idea, and that idea can come from a legislator, a staff member, a professional lobbyist, or an "average citizen." Legislation succeeds or fails depending on a number of factors. Advocacy organizations represent the views of like-minded individuals when it comes to supporting or opposing bills, but the most powerful voice still



belongs to the individual constituent. It may seem as if one person cannot affect the legislative process. Conventional wisdom holds that the political process is corrupt, and the government is broken. Politicians don't listen to an average citizen. Legislators can't get anything done.

#### What influences elected officials?

Most importantly... their constituents: A common refrain in any elected official's office

is, "How does this impact my constituents?" It is the lens through which many or most decisions are made.

Why is it important to ask for something specific?

Asking for something specific is often the most effective way to get an elected official's attention. Your objective is to encourage someone in the office to think for more than a few minutes about the issues that you have brought to his or her attention; making a clear and concise "ask" helps you to achieve that goal.

#### Let's make this happen!

You have been delivering for America in a time of crisis and now it's time for the Congress of America to deliver for you. Tell your Congress representatives to support Postal Reform.

We just had our State Training for steward's college. Huge thanks out to our NBA's office. NBA Dan Versluis covered grieving management's mistakes while filing Workman's Compensation (OWCP) or lack thereof, as well as filing a CA-1 for COVID absences. If you have a workplace



injury, make sure management fills out a paper copy of the CA-16 for you to take to the doctor. This form authorizes the doctor's office to bill OWCP, without it, you will be receiving the bill. CA-1 is for traumatic injuries such as a trip and fall, sprained ankle. CA-2 is for injuries that happen over time such as rotator cuff or a carpel tunnel. You don't have to use Concentra, but you do have to use a doctor's office that accepts Workman's

Comp payments. As always, keep copies of everything.

John Robles did a great presentation on route protection during route counts. With all the light mail volumes notorious this time of year, I expect management to start the shenanigans and initiate some route counts to try to absorb a few routes. Best advice I can give, is to carry your route everyday as if you were being given a route count. For overburdened routes, you need to have 30 minutes of overtime, three days a week, for six consecutive weeks to qualify for a 6-day inspection. Routes consistently showing undertime will be added to. Protect your route; take your breaks, comfort stops, and lunch.

John Beaumont did a great job on the Letter Carrier Political Fund. I especially liked the approach of not alienating one political party or another. Here in Colorado, we have plenty of fellow carriers on each side of the political line. The Letter Carrier Political Fund (LCPF) is a bipartisan political PAC (because not one cent of your Union dues is used towards political gains) with the sole purpose of keeping us in a job.

Looking forward to seeing all of you at State Convention.

Welcome to 2022, it's going to be a great year!

Thanks to your help and strategic calls, HR 3076 (Postal Service Reform Act of 2021) has just been cleared for a final mark-up vote out of the Ways and Means Committee. The next step is moving it to the House



Floor for a vote. A final floor vote won't come till they return to DC after the holiday recess. We still your need your help to immediately engage your membership to contact their representatives and ask for their support for HR 3076 when it comes up for a vote. Getting the wordout now will only help reinforce getting the crucial votes we need for final passage out of the House.

Here is an example of how easy it is to

contact your representatives. Doug Jaynes, Colorado State Association Vice president and a member of Branch 47, got up during the Branch meeting to speak. He was talking to the membership about the need to contact our representatives and how easy it is to make a call. Doug had his cell phone in one hand trying to dial a number and a microphone in the other hand. He was trying to juggle the microphone and his phone because we were doing a zoom hybrid meeting all the while trying to look into the computer screen.

He paused then started talking to Senator Hickenlooper's office and leaving a message to please support the ALS bill and to please be a sponsor on the HR 3076 bill. Doug stated his name and that he was a member of the National Association of Letter Carriers and would appreciate his sponsoring the bills thanking him, then hung up. The whole process took about a minute, but it has a big impact. For additional guidance go to the NALC app and click the Take Action tab. You will find examples of e-mails, talking points and how to contact your representitve with phone numbers and addresses.

As always, the political landscape is a challenging and polarizing one. But for us letter carriers, our position should be clear and easy to express...get postal reform PASSED through Congress and eliminate the prepayment provisions of the 2006 Postal Accountability and Enhancement Act.



Under this Act the postal service has been required to PRE-PAY health care benefits for retirees, on employees that have not even been hired yet. We have already paid billions of dollars into a fund that can't be used for anything else; not for new vehicles, not for modernization of our facilities - nothing. This makes no financial sense and is not required of any other public or private business.

It is for this reason alone that the postal service appears to be in the red even though we make a profit on operations annually! Don't let the rumors spread that we are no longer what we used to be and our "business" model is not sound. We are a service to the American people; one they still want and need. Our popularity continues to remain high

and if Congress would just ACT and let us grow our favored rating would continue to soar.

We need to pass HR 3076 -the Postal Service reform Act NOW. You will be called on to help in contacting your house representative, please do so. You can start now by going to NALC.org legislative page and take action. This is what the PEOPLE of Colorado want, not just us letter carriers. Get your family involved, talk to friends and neighbors. Together we will be heard all the way to Washington DC!

The 2022 Stewards College put on by our very own National Business Agent are always full of vital and key information. Many things that should be no-brainers but are always good reminders; have good relations with your management team but don't get too chummy with them and always Always ALWAYS get everything in writing. As the



saying goes, "it's not what you know, it's what you can prove." This goes for everything from information requests to what you put in the grievance file.

CCA's in their first 90 days who get threatened to get fired for getting hurt is a whistle-blower OSHA complaint. Concentra is not the only place injured postal employees can go to. Rights are violated if management does not say or tell employees that they can find their own

doctor. With COVID still being a thing, any carrier that have tested positive should file a claim in ECOMP ( https://www.ecomp.dol.gov/#/) you will need a positive PCR test result to file a claim. Meaning NOT an at-home test kit, it has to be from a doctor's visit or testing center. It would behoove those that have had COVID to file thus claim ASAP since we still don't know the possible lasting effects. It could also mean the difference between the individual footing the whole bill down the road or having the Post Office help with medical bills in the future.

The NBA gave a great course on Route Inspections and explaining in detail how the process is supposed to go. The key take-aways are: the M-39 handbook is a great resource of information. If you have dps, flats, valpaks, advos, marriage mail, etc. the carrier can consolidate it all so they have at max no more than THREE bundles they can carry. There are time allowances for office work, but there are no street standards. Management may make exceptions to normal office standards for carrier with over 25 years of continuous service or those who are over the age of 55 (M-39 section 242.214).

Overall lots of valuable material and information was shared. It's up to us as stewards to always keep learning and if we don't know the answer then to ask those that do and to pass along the information to new and old carriers. With knowledge comes power, let's share it with each other.

Last year, the House passed H.R. 716 which cleared S. 1301, a bill that passed in the Senate to increase the public debt limit by \$480 billion. President Biden subsequently signed the bill into law. This package includes \$7 billion in proposed funding to include electric vehicles in the Postal Service vehicle fleet and provide the necessary infrastructure to support these vehicles. As we all know, we desperately need the next generation delivery vehicle (NGDV) fleet to replace the LLVs like yesterday, and hopefully being able to add electric vehicles will help with the longevity of our fleet. We will see what happens.

The Postal Reform Act of 2021, HR 3076 and S 1720, are slowly but surely gaining support. As of this writing, HR 3076 has 102 cosponsors and S 1720 has 27. He has also signed on in support of anti-privatization bill, restoration of postal service standards, keeping 6-day delivery, door to door delivery, social security fairness, repeal of pre-funding, and the Federal Retirement Fairness Act. All these issues would benefit letter carriers and the Postal Service.

I attended a zoom meeting with Jason last week. Other issues that he is working on are bills to prevent price gouging on prescription drugs, voter protection rights, Made in America Act and college loan relief.

This year the Congressional elections are extremely important. We need to keep our friends in Congress by re-electing Jason Crow, keeping a friendly person in CD 7 and electing a favorable person in the new CD 8. We must work hard to protect our jobs.

#### H.R. 3076 UPDATE

House passes Postal Service Reform Act

Today, in a 342-92 vote the House of Representatives passed the Postal Service Reform Act of 2022 (H.R. 3076). NALC President Fredric Rolando called the passage "a huge victory for the American people, who rely on the Postal Service for affordable and high-quality universal service."

The strongly bipartisan bill includes key measures to strengthen the Postal Service, including provisions that eliminate the mandate on the Postal Service to pre-fund its retiree health care benefits decades in advance and that codify the requirement to provide six-day mail delivery. It also includes provisions to reduce postal health care costs by maximizing participation in Medicare on a prospective basis.

The legislation, which was drafted by Committee on Oversight and Reform (COR) Chairwoman Carolyn Maloney (D-NY), Ranking Member James Comer (R-KY), COR Subcommittee Chairman Gerry Connolly (D-VA) and Committee on Education and Labor Ranking Member and COR member Virginia Foxx (R-NC), reflects a broad bipartisan consensus that was 15 years in the making and that has the support of the four postal unions, the mailing industry and Postal Service management.

"NALC commends Chairwoman Maloney and Ranking Member Comer for their bipartisan leadership to get this momentous bill passed in the House," NALC President Rolando said. "We also appreciate every House member who supported this bill by voting "yes."

"With House passage, we are one step closer to dramatically improving the financial stability of the Postal Service. We call on the Senate to debate and pass H.R. 3076 as soon as possible—and then to send it to President Biden for his signature.

"I want to congratulate and thank all the NALC members who lobbied their members of Congress to win House passage and urge them to help finish the job by contacting their senators to urge them to vote for H.R. 3076."

#### **Wounded Warrior Leave**

#### **Definitions**

Wounded Warriors Leave is an authorized absence from the Postal Service to undergo medical treatment for a service-connected disability rated at 30 percent or more. It is a separate leave category, distinct from sick leave.

Treatment is an in-person visit to a health care provider, as specified in Section 513.364 of the Employee and Labor Relations Manual (ELM), and includes the course of action prescribed by a health care provider.

Treatment includes but is not limited to examination for and evaluations of the health condition that has caused the disability rating.

Health Care Provider is the employee's attending physician or otherattending practitioner as recognized by ELM 515.2.

Leave Year means the period beginning on the first day of the first pay period of the calendar year, concluding with the last day of the last payperiod of the calendar year. It is the period during which an employee may use Wounded Warriors Leave.

#### **Eligible Employees**

All employees who have a single or combined service-connected disability rating of 30 percent or more are eligible for Wounded Warriors Leave. **Employees with Pending Disability Determinations** 

Otherwise eligible employees with pending disability determinations who at any time during any Leave Year receive a 30 percent or more disability rating will be eligible for leave retroactively to the first day of that current Leave Year. Any leave without pay (LWOP) or leave used while the determination is pending will be reimbursed and replaced with Wounded Warriors Leave, as appropriate, up to the maximum number of hours allowed. Wounded Warriors Leave may be retroactively applied for only the most current Leave Year and for no more than 104 hours.

## Did you hear it's Easier to File FECA Claim for COVID-19 now

The American Rescue Plan Act of 2021 that President Biden signed on March 11, 2021, makes it **much easier** for federal workers diagnosed with COVID-19 to establish coverage under the Federal Employ Compensation Act. To establish a COVID-19 claim, you simply need to establish that you are a "cover employee," meaning that:

- You were diagnosed with COVID-19. Specifically, you were diagnosed with COVID-19 while employed in the Federal service at any time during the period of January 27, 2020 to January 27, 2023; and,
- 2. Your duties include any risk of exposure. Specifically, within 21 days of your diagnosis of COVID-19, you carried out duties that
  - a. required contact with patients, members of the public, or co-workers; or b. included a risk of exposure to the novel coronavirus.



#### What Does the Change in the Law Mean?

- You are only required to establish that your duties included a risk of exposure to COVID-19. You do not have to prove you were engaged in high-risk employment; that you were actually exposed to the virus; or that you were exposed to someone who had the virus while performing your duties.
- If you establish that you are a "covered employee," any diagnosed COVID-19 will be deemed to have been proximately caused by your Federal employment. You no longer have to establish a causal link between your employment and your employment and your COVID-19 diagnosis.



#### What to Do:

You can quickly and easily file a CA-1 Claim for COVID-19 through the Employees' Compensation Operations and Management Portal (ECOMP). You can access PORTAI (ECOMP). You can access ECOMP at ecomp.dol.gov, if you have never used ECOMP, you can yiew this instructional video to learn how to register for an ECOMP account, and this video to learn how to file a COVID-19 claim. If you don't have access claim. If you don't have access to a computer, contact your supervisor



## Why File Now? What if I Think I Am OK?

If you were previously diagnosed with COVID-19 or even if you believe you just have a mild case of COVID-19, you should consider filing a COVID-19 FECA claim now even if you have fully recovered and/or had an asymptomatic infection.

- In the event you develop a consequential Injury, Impairment or Illness later as a result of your COVID-19 diagnosis, timely filing your claim now will facilitate the processing of any future claim for any such consequential condition or Impairment.

  If you wait until you experience a consequential Injury or Illness to file your COVID-19 claim, your claim may be subject to time limitation and you will have to establish both the Initial COVID-19 claim and the consequential condition claim consequential condition claim before benefits can begin.
